- ENTRY:** Theme 'Grinch Stole Christmas'. **Must have holiday lights**, not exceed 13'6" height and 15'0" width, business/organization name (if any) on both sides of float, and have a signed waiver form to participate.
- FEES:** \$20 covers both Junction City & Harrisburg parades (no fee for Monroe). If a vehicle club, the fee is \$20 per vehicle or \$100 total for Junction City and Harrisburg, whichever is less. **Must have holiday lights.**
- DEADLINE:** Register by **3 PM, FRIDAY NOVEMBER 29TH (no registration at event)**. Email the registration form to info@tri-countychamber.com or drop it off at **355 W 6th Ave in Junction City**.
- SANTA:** There is a limit of **one Santa** per parade. Santas have already been selected. No more Santas.
- CANDY:** Walkers **may hand out** store-purchased candy or treats. **No throwing** from floats or vehicles.
- WALKERS:** At least two walkers aged 14 or older are required with each entry to ensure safety.
- RIDERS:** For safety, please do **NOT** jump off or on floats on the parade route or exceed float capacity.
- DRIVERS:** Must possess a **valid driver's license** and **liability vehicle insurance** and be at least 18 years old.
- RAILROAD:** When crossing tracks, be aware of the length of your float. Trains are active. **Do NOT stop on track!**
- ALCOHOL:** Cannot be consumed by parade participants before, during the parade, or in the line-up area.
- PUBLIC SAFETY:** No activities that could endanger public safety. Move float to the side if you break down.
- LITTER/WASTE:** Entries shall **NOT** cause trash or debris to be left on roads or sidewalks. **Animal entries must have a pooper-scooper** follow them to clean up waste from your animals. This is YOUR responsibility.
- STAGING:** 6:00-6:45 pm. Check-in at the registration desk in the staging area. Judging 6:30-6:50 pm.

Registration/Fee: Drop off or email form and \$20 (Junction City/Harrisburg) to info@tri-countychamber.com or to our office at 355 W 6th Ave in Junction City **by November 29!** *If in the Monroe parade only, there is no fee.*

Event Waiver: In consideration of the Tri-County Chamber of Commerce, the Monroe Rural Fire Protection District, the cities of Junction City, Harrisburg, and Monroe, and all volunteers (cumulatively hereinafter referred to as the **Light Parade**), I/We hereby waive and release any and all rights and claims of any nature that I/We may have against the Light Parade, their officers, employees, agents, assignees, licensees, volunteers, and cooperating entities for and against any and all injuries and damages of any nature which I/We may suffer while taking part in any activities connected with this event. This release shall be binding upon my/our heirs, executors, administrators, and/or assigns. I/We have read and agree to abide by all Light Parade guidelines including:

- **Must have holiday lights** and **business/organization/club/individual name** on both sides of the float. If your vehicle or float does not have holiday lights on, you will not be allowed in the parade line-up. No exceptions!
- Entry **cannot exceed** 13'6" height and 15'0" width.
- Limit of **one Santa** per parade, which has already been selected so no additional Santas.
- Walkers **may hand out** store-purchased candy or treats. **No throwing** from floats or vehicles for safety.
- At least **two walkers** aged 14 or older are required with each entry to ensure safety.
- Please, for safety, do **NOT jump off or on** floats on the parade route or **exceed the capacity** of the float.
- Drivers must possess a **valid driver's license** and **liability vehicle insurance**, be at least **18 years old**, and have **signed and dated this waiver** form.
- When crossing tracks, be aware of the length of your float. Trains are active. **Do NOT stop on/near tracks.**
- **Alcohol cannot be consumed** by parade participants before, during the parade, or in the line-up area.
- **No activities that could endanger** participants or spectators. Move float to the side if you break down.
- Entries shall **NOT cause trash or debris** to be left on roads or sidewalks. **Animal entries must have a pooper-scooper** follow them to clean up waste from your animals. This is your responsibility and will be enforced!
